SETTLEMENT

The following Settlement is hereby agreed to between International Paper Company, who purchased Weyerhaeuser Company's Red River Mill ("Respondent") and the Department of Environmental Quality ("DEQ" or "the Department"), under authority granted by the Louisiana Environmental Quality Act, La. R.S. 30:2001, et seq. ("the Act").

I

Respondent is a corporation that owns and/or operates a pulp and paper mill facility located in Natchitoches Parish, Louisiana ("the Facility").

II

The following Settlement is hereby agreed to between International Paper Company, who purchased Weyerhaeuser Company's ("Respondent's") Red River Mill (Agency Interest No. 2645), and the Department of Environmental Quality ("DEQ" or "the Department"), under authority granted by the Louisiana Environmental Quality Act, La. R.S. 30:2001, et seq. ("the Act"). In addition to Agency Interest No. 2645, the Consolidated Compliance Order & Notice of Potential Penalty, Enforcement No. AE-CN-07-0105, and the Amended Compliance Order and Notice of Potential Penalty, Enforcement No. AE-CN-07-0105A, also cited three other Weyerhaeuser facilities identified by Agency Interest Nos. numbers 3443, 4294, and 26547. Those facilities (Agency Interest Nos. 3443, 4294 and 26547) are not encompassed in

this settlement.

On October 31, 2007, the Department issued to Respondent a Consolidated Compliance Order & Notice of Potential Penalty, Enforcement No. AE-CN-07-0105, which was based upon the following findings of fact:

“The Respondent owns and/or operates the Red River Mill (Agency Interest No. 2645), a pulp and paper mill located at 4537 Louisiana Highway 480 in Campti, Natchitoches Parish, Louisiana. The facility currently operates under Title V Permit No. 1980-00004-V1, issued on April 30, 2007.

On or about August 29, 2007, a file review of the Red River Mill (Agency Interest No. 2645) was performed to determine the degree of compliance with the Act and the Air Quality Regulations. While the Department’s investigation is not yet complete, the following violations were noted during the course of the file review:

- A. According to the quarterly 40 CFR 63 Subpart MM Reports (MACT II) for the 2004 through 2006 calendar years, and the first and second quarter of 2007, the Respondent reported the following opacity deviations for Recovery Boiler No. 1 (Emission Point EQT003):

Each failure to control the emission of smoke from Recovery Boiler No. 1 so that the shade or appearance of the emission is not

darker than 40 percent average opacity is a violation of LAC 33:III.2301.D.4, Specific Requirement No. 22 of Title V Permit No. 1980-00004-V0, LAC 33:III.501.C.4, La. R.S. 30:2057(A)(1), and 30:2057(A)(2). The unauthorized release on January 17, 2007, that began at approximately 4:57 AM and ending at approximately 6:42 AM is also a violation of LAC 33:III.905.
