## DEQ

UPDATED: March 8, 2019

The following is a summary of actions taken by the Department of Environmental Quality with adoption, amendment, or repeal of proposed rules and of actions taken by the agency with respect to adoptions, increases, or decreases. Included are actions January 1, 2018, to February 28, 2019.

Proposed dates are those on which the notice of intended action was published in the Louisiana Register pursuant to La. R.S. 49:953. Public hearing dates are those on which the agency held public hearings pursuant to La. R.S. 49:953. Oversight hearing dates are those on which oversight hearings were conducted pursuant to La. R.S. 49:968. Final dates are those on which the actions were published in the Louisiana Register pursuant to La. R.S. 49:954.

AQ370ft - 2017 Annual Incorporation by Reference of Certain Federal Air Quality Regulations  
LAC 33:III.506, 507, 2160, 3003, 5116, 5122, 5311, and 5901

This rule incorporates by reference (IBR) into the Louisiana Administrative Code (LAC), Title 33, Part, Air, the following federal regulations included in the July 1, 2017 edition of the Code of Federal Regulations (CFR): 40 CFR Parts 51, Appendix M, 60, 61, 63, 68, 70.6(a) and 96. Any exception to the IBR is explicitly listed in the rule. The rule updates the references to July 1, 2017, for Standard of Performance for New Stationary Sources, 40 CFR Part 60. It also updates the references to July 1, 2017, for the National Emission Standards for Hazardous Air Pollutants (NESHAP) and for NESHAP for Source Categories, 40 CFR Part 61 and 63.

In order for Louisiana to maintain equivalency with federal regulations, certain regulations in the most current Code of Federal Regulations, July 1, 2017, must be adopted into the Louisiana Administrative Code (LAC). This rulemaking is also necessary to maintain delegation authority granted to Louisiana by the Environmental Protection Agency.

AQ376ft - Definition of Major Source  
LAC 33:III.502.A

This rule will revise the definition of "major source" in LAC 33:III.502.A to parallel the federal definition of the term at 40 CFR 70.2.

A "major source" is a stationary source or group of stationary sources that are located on one or more contiguous or adjacent properties, that are under common control of the same person (or persons under common control), and that meet certain additional criteria, such as having the potential to emit air pollutants at or above prescribed thresholds. On June 3, 2016, the U.S. Environmental Protection Agency (EPA) promulgated a rule entitled "Source Determination for Certain Emission Units in the Oil and Natural Gas Sector" (81 FR 35622). This rule amended the definition of major source in 40 CFR 70.2 to stipulate the circumstances under which EPA would consider two or more nominally separate onshore crude oil and natural gas production operations to be adjacent.

Although adoption of the amended definition is not mandatory, LDEQ published a Potpourri Notice (1607Pot2) in the July 20, 2016, Louisiana Register explaining that the department will "now interpret the term adjacent consistent with the definitions of major source under 40 CFR 70.2 and building, structure, facility, or installation under 40 CFR 51.165(a)(1)(ii) and 40 CFR 51.166(b)(6) in order to be consistent with federal regulations."

AQ377 - Revision of Stage II Regulations Regarding Decommissioning Vapor Recovery Equipment  
LAC 33:III.2132

Currently LAC 33:III.2132 Stage II requires certain Motor Vehicle Fuel Dispensing Facilities (MVDF) to install vapor recovery equipment as required by Section 202(a)(6) of the Clean Air Act. The U.S. Environmental Protection Agency (EPA) has determined that the systems used at gas station pumps to capture gasoline vapors while refueling cars can be phased out. Modern vehicles are equipped to capture those emissions with onboard refueling vapor recovery (ORVR) technologies.

This Rule will amend § 2132 to: (1) terminate the requirement to install Stage II Vapor Recovery Systems at new MVDF; (2) provide standards and requirements for decommissioning existing Stage II equipment at MVDF; and (3) require the decommissioning of existing Stage II equipment within eighteen months of final approval of a SIP revision by the US EPA to eliminate Stage II requirements.

MM020 - Fee Increase - Miscellaneous Amendments and Corrections  
LAC 33:I.1203, 1911; III.211, 223, 307, 309, 319; V.5123, 5139, and IX.1309

This Rule provides for miscellaneous amendments and corrections necessary for fee changes authorized by Act 451 of the 2016 Regular Legislative Session. This Act authorized certain fee increases, new fees and other changes to the regulations pertaining to fees. This Rule is required to correct errors found during the implementation of MM018, the original fee increase Rule.

WQ098ft - Correction to LAC 33:IX.7117. Appendix I  
LAC 33:IX.7117

This Rule will include East Baton Rouge Parish as a parish with an unincorporated urbanized area greater than 100,000, but less than 250,000 according to the 1990 Decennial Census by the Bureau of the Census. This can be found at 64 FR 68849, December 8, 1999. The US Environmental Protection Agency finalized the Phase II stormwater regulations on December 8, 1999, to address discharges of storm water from small municipal separate storm sewer systems (MS4s). As part of this rule, EPA also updated the list of designated Phase I MS4s, which are included in 40 CFR 122, Appendix I. This update included the addition of unincorporated areas of East Baton Rouge Parish as a Phase I MS4. The incorporated area of Baton Rouge was previously listed in the 1990 Phase I storm water rule. LDEQ subsequently adopted the Phase II stormwater regulations in the rule, log number WQ039, finalized on October 20, 2000. Updates to LAC 33:IX.7117 (the corresponding section to 40 CFR 122, Appendix I) were inadvertently omitted from the 2000 rule. This Rule will correct that omission.

AQ380 - Project Emissions Accounting and Offset Requirements in Specified Parishes  
LAC 33:III.504

This Rule will remove phrases from LAC 33:III.504 that explicitly preclude emissions decreases associated with a proposed project from being considered in determining whether the project results in a significant emissions increase.

It will also delete obsolete language from Footnote 4 of Table 1 and remove Livingston Parish from the list of parishes in which offsets for certain new stationary sources and modifications are required under LAC 33:III.504. It will also delete obsolete language from Footnote 4 of Table 1 and remove Livingston Parish from the list of parishes in which offsets for certain new stationary sources and modifications are required under LAC 33:III.504.

As described in EPA's March 13, 2018, memorandum entitled "Project Emissions Accounting Under the New Source Review Preconstruction Permitting Program," EPA now interprets the provisions of the federal New Source Review (NSR) programs "as providing that any emissions decreases that may result from a given proposed project are to be considered when calculating at Step 1 whether the proposed project will result in a significant emissions increase." Previously, only emissions increases were considered in determining whether a proposed project resulted in a significant emissions increase and therefore triggered consideration of the net emissions increase over the project's contemporaneous period (i.e., Step 2), even if emissions decreases were inherently linked to the project.

Accordingly, phrases which explicitly preclude emissions decreases associated with a proposed project from being considered in determining whether the project results in a significant emissions increase are being removed from LAC 33:III.504.

The reference to "a period of five years after the effective date of the rescission of the NOx waiver" is also being removed from Footnote 4 of Table 1 in Chapter 504. EPA rescinded Baton Rouge's Section 182(f) NOx exemption (i.e., the NOx waiver) on May 5, 2003, effective June 4, 2003 (68 FR 23597). Therefore, a newly proposed project could not fall within the aforementioned date range.

Finally, Livingston Parish is being removed from the list of parishes in which offsets for certain new stationary sources and modifications are required under LAC 33:III.504.M. Livingston Parish has only four Part 70 sources (AIs 9154, 11767, 19875, and 80537). Notably, none of the four are major sources of NOx, and only on (AI 19875) is a major source of VOC. Further, actual 2017 NOx and VOC emissions reported to LDEQ's Emissions Reporting and Inventory Center (ERIC) by owners/operators of facilities located in Livingston Parish comprised only 0.7 percent and 2.5 percent of total NOx and VOC emissions, respectively, reported by owners/operators of facilities located in five parishes in which offsets may presently be required (i.e., Ascension, East Baton Rouge, Iberville, Livingston, and West Baton Rouge).

RP062ft - Miscellaneous Corrections to Radiation Regulations  
LAC 33:XV.102, 328, 342, 390, 499, 763, 1519, 1613, 1615, and 1637

This Rule makes minor changes to recordkeeping, reciprocity and physical protection. Also, all references to Indian tribes are changed to Indian Tribes. This Rule was promulgated by the Nuclear Regulatory Commission (NRC) as RATS ID 2015-4 and 2015-5. This Rule will update the state regulations to compatible with changes in the federal regulations. The changes in the state regulations are category B, C and H&S requirements for the State of Louisiana to remain an NRC agreement state.

SW064 - Closure Requirements for Surface Impoundments  
LAC 33:VII.115 and 713.E

This Rule creates and defines risk-based closure standards for solid waste surface impoundments using the LDEQ Risk Evaluation/Corrective Action Program (RECAP). The proposed definitions and rule changes will allow for the closure of solid waste surface impoundments under RECAP equivalent to and in lieu of clean closure. This Rule also amends the definition of clean closure for solid waste surface impoundments.

Federal regulations, which became effective on August 12, 2008, clarified that water transfers are not subject to regulation under the National Pollutant Discharge Elimination System (NPDES) permitting program.

LAC 33:I.1307

This Rule will adopt by reference the revised Risk Evaluation/Corrective Action Program (RECAP) regulation which serve as the minimum remediation standards for soil and groundwater. The revisions to the RECAP regulation amend and update the program to be consistent with the most current scientific methods and recommendations to ensure that response actions to chemical releases in the environment are protective of human health and the environment. Text revisions include clarifications reorganization, and streamlining to facilitate the interpretation and application of the program.

LAC 33:XI.307

This Rule will correct the fee for storing new or used motor oil in underground storage tanks. R.S 30:2195.3 specifies a fee of \$275 for this storage. Act 451 of the 2016 Regular Legislative Session authorized certain fee increases, new fees and other changes to the regulations pertaining to fees. A change to the fee for storing new or used motor oil in an underground storage tank found in R.S. 30:2195.3 was not included in Act 451. This correction will make the fee in the regulation match the fee in the statute.

WQ099 - Water Quality Trading  
LAC 33:IX.2601, 2603, 2605, 2607, 2609, 2611, 2613, 2615, 2617, and 2619

In accordance with R.S. 30:2074(B)(9)(a), the LDEQ, through this Rule will establish and administer a water quality trading(WQT) program as an inducement to reduce discharges of pollutants into waters of the state. The WQT program is a strategy to help achieve the goals of the Clean Water Act (CWA). The WQT program is voluntary and relies on a market-based approach to offer economic incentives for pollutant reduction from point and nonpoint sources. Trading allows a source to meet its regulatory obligations by using pollutant reduction credits generated by another source that has lower pollution control costs. The Rule will address appropriate standards for accountability and enforceability and provisions to ensure transparency. This Rule will apply to various trading scenarios. This Rule enacts the revisions made by Act No. 371 of the 2017 Regular Session of the Louisiana Legislature.

SW065 - Recycling Tax Credit Reduction  
LAC 33:VII.10415

This Rule reduces the amount of the credit, related to purchase of qualified new recycling manufacturing, process equipment, and/or a qualified service contract pertaining to equipment, from 20 to 14 percent. Louisiana Revised Statute 47:6055 authorizes an income tax credit for purchase of new recycling manufacturing, process equipment, and/or a service contract pertaining to the equipment. Act 400 of the 2017 Regular Legislative Session made the reduction credit permanent for equipment or service contracts. The Rule implements the change in R.S. 47:6055.

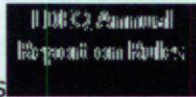
