EXPLANATION/EXAMPLES OF INSTITUTIONAL CONTROLS:

*Conveyance Notice* - A notice of contamination (nature and levels of contaminants) and restriction of property to non-residential use are placed in the conveyance records for the property.

*Fences/Perimeter Barrier* - Fences or other barriers are used on the property to prevent access by persons to areas where exposure could occur.

*Building/Construction Restriction* - Locations of buildings are restricted to prevent exposures or type/method of construction is limited or specified to prevent exposures, or construction worker notification is required. This might be a requirement for construction on above-ground piers or an active ventilation system to prevent vapor exposures.

*Excavation Restriction* - Digging in areas where exposures might occur is prohibited or guidelines for how and where to perform excavations are used.

*Groundwater Use Restriction* - Use of groundwater is prohibited or its use is limited to uses that would not cause exposures to humans (i.e., nonpotable uses).

*Non-Residential Use Restriction* - Property use limited to non-residential uses (e.g., appropriate commercial or industrial use only).

*Cap/Surface Soil Barrier Construction and Maintenance* - A surface barrier such as a synthetic or clay cap or concrete slab or other impermeable material is installed and maintained to prevent exposures of humans to subsurface contaminants.

*Subsurface Containment to Prevent Contaminant Migration* - An impermeable subsurface barrier such as a slurry wall is used to prevent subsurface contaminants from spreading from the contaminated areas.

*Future Right of Access to LDEQ* - Agreement is put in place to allow LDEQ or its authorized representatives to access the site to take whatever remedial measures are further needed at the site (e.g, remediation of remaining contamination or if institutional controls fail).
