Materials accepted

- ✓ Acids
- ✓ Aerosol cans
- ✓ Arsenic
- ✓ Auto products including used oil, antifreeze, brake fluid, diesel, oil & fuel filters
- ✓ Cooking oil
- ✓ Batteries including NiCD, lead acid, alkaline, rechargeable
- ✓ Bleach, bowl cleaners
- ✓ Bug sprays
- ✓ Wood preservatives
- ✓ Cleaning solvents
- ✓ Corrosive cleaners
- ✓ Degreasers
- ✓ Disinfectants
- ✓ Electronic Equipment
- ✓ Paint thinner
- ✓ Paint: latex and oil, stain, varnish, shellac
- ✓ Fluorescent tubes & compact fluorescent bulbs
- ✓ Glue
- ✓ Lawn and garden products including pesticides, herbicides, fungicides, fertilizer

Materials NOT accepted

- ✗ Ammunition, explosives
- ✗ Fireworks
- ✗ Non-residential waste
- ✗ Radioactive devices (smoke/fire detectors)
- ✗ Large gas cylinders such as helium, freon or acetylene
- ✗ Styrofoam including peanuts
- ✗ Construction/demolition debris
- ✗ School lab waste
- ✗ Fire extinguishers
- ✗ Appliances
- ✗ Furniture
- ✗ Power tools
- ✗ All liquids in containers larger than 5 gallons

How to dispose of Unusable Latex Paint –
Empty or dried-out latex paint cans should go into the garbage cart. For cans less than 1/4 full, open the lids, mix with an equal amount of kitty litter and let paint dry before setting out for disposal.
