LDEQ Hosts EPA Region 6 Administrator Scott Mason to Discuss Energy Dominance and **Economic Growth in the Industrial Corridor**



Baton Rouge, LA — This week, the Louisiana Department of Environmental Quality (LDEQ) had the honor of welcoming W. Scott Mason, U.S. Environmental Protection Agency (EPA) Region 6 Administrator, to the heart of Louisiana. This visit symbolizes our state's unwavering commitment to economic growth, energy dominance, and national security under Governor Jeff Landry, harmonizing with the Trump Administration's vision for America's revitalization. A highlight of the tour was the exploration of the Industrial Corridor along the Mississippi River, a region recognized as the economic breadbasket of our state and a cornerstone of the nation's energy landscape.

Discussions centered on regulatory reforms aimed at enhancing operational efficiency, dispelling out-of-state misconceptions about the Industrial Corridor, and rebuilding trust between communities and regulatory bodies.

A roundtable meeting with state legislators highlighted the economic potential of the industries within their districts. **Louisiana State Senator Ed Price** expressed optimism, stating "My meeting with Secretary Giacometto and Regional Administrator Mason was incredibly productive. We discussed practical solutions for improving our state's environmental health while promoting economic growth. I am confident that the Secretary's leadership will guide Louisiana toward a cleaner, more sustainable future."

The guided tour provided Region 6 Administrator Mason with a close-up view of the innovation and efficiency driving leading refinery and petrochemical companies, including visits to Exxon Mobil and Shintech, the world's largest producer of polyvinyl chloride (PVC). Spanning the parishes of St. John the Baptist, St. James, and St. Charles, this region is not only vital to Louisiana's economy but also to the overarching energy sector in the United States.

The tour concluded at the Port of South Louisiana, where Region 6 Administrator Mason engaged with the presidents of the three River Parishes and representatives from the refinery and petrochemical sectors - Dow, Chevron Norco, BASF, Shell, and AirProducts – and supporting industries – Bosco, Rollo Security, Maintenance Dredging, and others. They discussed proactive measures to reduce emissions, community commitments, and the challenges posed by excessive regulations.
