ENVIRONMENTAL CRIME INVESTIGATION TECHNIQUES

August 4-7, 2015 Belle of Baton Rouge Hotel

- What:** This course covers the specialized methods and techniques unique to environmental crime investigations. Topics include: the criminal provisions of the environmental statutes, environmental search warrant preparation and execution, personal protection and safety, environmental sampling and chemistry, preparing and presenting your case to the prosecutor. The course emphasizes the “multi-disciplined, teamwork approach” which relies on the involvement of regulatory personnel, law enforcement officers and prosecutors. The course also includes a practical exercise during which students will work in teams to address many of the common issues associated with environmental crime investigations and prosecutions. This course qualifies as a pre-requisite to the Advanced Environmental Crime Training Program (AECTP) presented at the Federal Law Enforcement Training Center (FLETC) in Glynco, Georgia. The AECTP is regarded as the premiere advanced training course for environmental enforcement professionals throughout the US and Canada.
- Who:** The course is designed for local, state and federal regulatory personnel, law enforcement officers, code enforcers, fire marshals and other personnel who may encounter evidence of environmental felony and misdemeanor level criminal activity. Students who complete the course will receive a Certificate of Completion.
- When:** August 4-7, 2015. Class will begin in the afternoon of August 4th and conclude at 12noon on August 7th. Deadline for registration is July 15, 2015.
- Where:** Belle of Baton Rouge Hotel, 103 France Street, Baton Rouge, Louisiana. The hotel is offering a \$79/night rate for those registered for the training course.
- How:** Registration is free to local, state and federal personnel from Louisiana. However, you must register with the Southern Environmental Enforcement Network (SEEN) using the registration included with this announcement. Once you receive your confirmation information from us, please contact the hotel and make your own reservations. There are a limited number of seats available for this course and they are being allocated on a “first come, first served” basis. Tell the hotel you are making a reservation under the Southern Environmental Enforcement Network block to receive the \$79/night rate.
