SETTLEMENT

The following Settlement is hereby agreed to between LaSalle Bioenergy LLC (“Respondent”) and the Department of Environmental Quality (“DEQ” or “the Department”), under authority granted by the Louisiana Environmental Quality Act, La. R.S. 30:2001, et seq. (“the Act”).

I

Respondent is a limited liability company that owns and/or operates wood pellet manufacturing facility located in LaSalle Parish, Louisiana (“the Facility”).

II

On October 30, 2019, the Department issued to Respondent a Consolidated Compliance Order & Notice of Potential Penalty, Enforcement Tracking No. AE-CN-19-00961 (Exhibit 1).

On November 14, 2019, the Department issued to Respondent a Consolidated Compliance Order & Notice of Potential Penalty, Enforcement Tracking No. MM-CN-17-00980 (Exhibit 2).

On October 27, 2020, the Department issued to Respondent a Consolidated Compliance Order & Notice of Potential Penalty, Enforcement Tracking No. SE-CN-20-00592 (Exhibit 3).

On November 17, 2021, the Department issued to Respondent an Amended Consolidated Compliance Order & Notice of Potential Penalty, Enforcement Tracking No. MM-CN-17-00980A (Exhibit 4).

III

In response to the Consolidated Compliance Order & Notice of Potential Penalty (MM-CN-17-00980), Respondent made a timely request for a hearing.

IV

Respondent denies it committed any violations or that it is liable for any fines, forfeitures and/or penalties.

V

Nonetheless, Respondent, without making any admission of liability under state or federal statute or regulation, agrees to pay, and the Department agrees to accept, a payment in the amount of ONE MILLION SIX HUNDRED THOUSAND AND NO/100 DOLLARS (\$1,600,000.00), of which Seven Thousand Three Hundred Thirty and 31/100 Dollars (\$7,330.31) represents the Department's enforcement costs, in settlement of the claims set forth in this agreement. The total amount of money expended by Respondent on cash payments to the Department as described above, shall be considered a civil penalty for tax purposes, as required by La. R.S. 30:2050.7(E)(1).

VI

Respondent further agrees that the Department may consider the inspection report(s), permit record(s), the Consolidated Compliance Orders & Notices of Potential Penalty, Amended Consolidated Compliance Order & Notice of Potential Penalty and this Settlement for the purpose of determining compliance history in connection with any future enforcement or permitting action by the Department against Respondent, and in any such action Respondent shall be estopped from

objecting to the above-referenced documents being considered as proving the violations alleged herein for the sole purpose of determining Respondent's compliance history.

VII

This agreement shall be considered a final order of the Secretary for all purposes, including, but not limited to, enforcement under La. R.S. 30:2025(G)(2), and Respondent hereby waives any right to administrative or judicial review of the terms of this agreement, except such review as may be required for interpretation of this agreement in any action by the Department to enforce this agreement.

VIII

This settlement is being made in the interest of settling the state's claims and avoiding for both parties the expense and effort involved in litigation or an adjudicatory hearing. In agreeing to the compromise and settlement, the Department considered the factors for issuing civil penalties set forth in La. R. S. 30:2025(E) of the Act.

IX

As required by law, the Department has submitted this Settlement Agreement to the Louisiana Attorney General for approval or rejection. The Attorney General's concurrence is appended to this Settlement Agreement.

X

The Respondent has caused a public notice advertisement to be placed in the official journal of the parish governing authority in LaSalle Parish, Louisiana. The advertisement, in form and wording approved by the Department, announced the availability of this settlement for public view and comment and the opportunity for a public hearing. Respondent has submitted an original proof-of-publication affidavit and an original public notice to the Department and, as of the date this

Settlement is executed on behalf of the Department, more than forty-five (45) days have elapsed since publication of the notice.

XI

Payment is to be made within ten (10) days from notice of the Secretary's signature. If payment is not received within that time, this Agreement is voidable at the option of the Department. Payments are to be made by check, payable to the Department of Environmental Quality, and mailed or delivered to the attention of Accountant Administrator, Financial Services Division, Department of Environmental Quality, Post Office Box 4303, Baton Rouge, Louisiana, 70821-4303. Each payment shall be accompanied by a completed Settlement Payment Form (Exhibit A).

XII

In consideration of the above, any claims for penalties are hereby compromised and settled in accordance with the terms of this Settlement.

XIII

Each undersigned representative of the parties certifies that he or she is fully authorized to execute this Settlement Agreement on behalf of his or her respective party, and to legally bind such party to its terms and conditions.

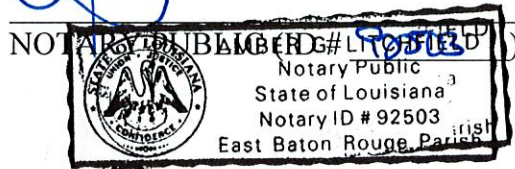



CONSOLIDATED
COMPLIANCE ORDER & NOTICE OF POTENTIAL PENALTY

The following **CONSOLIDATED COMPLIANCE ORDER & NOTICE OF POTENTIAL PENALTY** is issued to **LASALLE BIOENERGY LLC (RESPONDENT)** by the Louisiana Department of Environmental Quality (the Department), under the authority granted by the Louisiana Environmental Quality Act (the Act), La. R.S. 30:2001, et seq., and particularly by La. R.S. 30:2025(C), 30:2050.2 and 30:2050.3(B).

FINDINGS OF FACT

I.

The Respondent owns and/or operates a wood pellet manufacturing facility (the facility) located at 4915 Louisiana Highway 125 in Urania, LaSalle Parish, Louisiana. The facility operates or has operated under the authority of the following permits:

On or about June 14, 2017, the Department received a Notification of Change (NOC-1) Form requesting changes for the facility and the pellet processing facility (Agency Interest Number 1565).

According to the NOC-1, the company name, the facility name, ownership, and permits transferred effective April 25, 2017, from German Pellets Louisiana, LLC, (German Pellets) to the Respondent. German Pellets assumed responsibility for all violations existing prior to the transfer of the permits. The Department effectively transferred the permits and updated records to reflect the changes on August 31, 2017.

II.

On or about April 16, 2019, the Department reopened Title V Permit No. 1680-00097-V2 issued on August 27, 2018, in response to comments received during the public comment period for the permit renewal. The permit was reopened to establish additional testing, monitoring, and recordkeeping requirements necessary to assure compliance with the terms and conditions of the permit.

III.

On or about October 4, 2019 and October 28, 2019, the Department conducted file reviews to determine the Respondent's degree of compliance with the Act, the Air Quality Regulations, and all applicable permits. While the Department's investigation is not yet complete, the following violations were noted during the course of the file reviews:

- A. In a Compliance Plan dated August 23, 2019, and a Request for Compliance Order dated September 16, 2019, the Respondent reported that voluntarily VOC emissions testing was conducted in late July 2019. The results of the testing revealed two (2) pellet coolers, Cooler Air Aspiration Line 1 Filter 1 (EQT 0021) and Cooler Air Aspiration Line 1 Filter 2 (EQT 0022), exceeded the VOC tons per year (tpy) limit, 17.70 tpy per cooler, by 367 tpy. Each exceedance of a permitted limit is a violation of Title V Permit No. 1680-00097-V2, Specific Condition No. 2 of Prevention of Significant Deterioration (PSD) Permit No. PSD-LA-773(M-1), LAC 33:III.501.C.4, and La. R.S. 30:2057(A)(1) and 30:2057(A)(2). The Respondent requested a compliance schedule for engineering and installing VOC emissions controls. The Respondent proposed installing a Regenerative Catalytic Oxidizer (RCO) to control significant VOC emissions from significant VOC sources other than the dryer. VOC emissions from the dryer are controlled using a Regenerative Thermal Oxidizer (RTO).
- B. The Respondent is currently operating the facility under PSD Permit No. PSD-LA-773(M-1) issued on November 14, 2014, and Title V Permit No. 1680-00097-V2 issue on August 27, 2018. Each Dry Mill Aspiration Line Filters (EQT 0009 through EQT 0016) is permitted for 51.32 tpy of VOC and each Cooler Air Aspiration Line Filters (EQT 0021 through EQT 0024) is permitted for 17.70 tpy. The Best Available Control Technology (BACT) analysis and air quality analysis conducted for PSD Permit No. PSD-LA-773(M-1) were based on the permitted emissions. The Regenerative Thermal Oxidizer (RTO) and Regenerative Catalytic Oxidation (RCO) control technologies for the sources were rejected based on the cost effectiveness; the sources emitted to the atmosphere without any controls. In a Request

for Compliance Order dated September 16, 2019, the Respondent reported two of the Cooler Air Aspiration Lines, EQT 0021 and EQT 0022, exceeded the combined VOC tpy of 35.4 by 367 tons. The higher VOC emissions require a modified PSD and a new BACT analysis. Failure to operate the facility in accordance with the permitted VOC limits and BACT analysis is a violation of Specific Requirement 71 of Title V Permit No. 1680-00097-V2, LAC 33:III.501.C.4 and LAC 33:III.509.

- C. The Respondent failed to conduct a performance/emissions test as required by Title V Permit No. 1680-00097-V2 issued on August 27, 2018. Per Specific Requirement 10 of Title V Permit No. 1680-00097-V2, the Respondent was required to conduct a performance/emissions test within 180 days after the issuance of Title V Permit No. 1680-00097-V2 or within sixty (60) days of startup if the source is not operational when the performance/emissions test was due. The Respondent was required to conduct a stack test on one (1) of the Cooler Air Aspiration Line stacks (EQT 0021 through EQT 0024). The Department has not received a test notification or performance test results demonstrating the required performance/emissions test was conducted. Failure to conduct a performance/emission test within the required period is a violation of Specific Requirement 10 of Title V Permit No. 1680-00097-V2, Specific Condition No. 1 of PSD Permit No. PSD-LA-773(M-1), LAC 33:III.501.C.4, and La. R.S. 30:2057(A)(2).

COMPLIANCE ORDER

Based on the foregoing, the Respondent is hereby ordered:

I.

To take, immediately upon receipt of this **COMPLIANCE ORDER**, any and all steps necessary to meet and maintain compliance with the Air Quality Regulations and all applicable permits.

II.

The Department has reviewed the compliance plan for the engineering and installation of VOC control equipment to address the violations cited in Paragraph III.A-B of the **FINDINGS OF FACT** portion of the action and hereby orders the Respondent to implement the following milestones to achieve compliance:

The Respondent shall notify the Department in writing of any changes to the approved compliance schedule within seven (7) days of notice/discovery of failure to meet the due dates.

III.

To submit to the Enforcement Division monthly progress reports until the issuance of the modified Title V permit. The monthly progress reports shall include the following information: 1) the interim or permanent control technology, operational procedures, and/or corrective actions implemented to address the VOC emissions as related to the Paragraph III of the **FINDINGS OF FACT** portion of this action; 2) status of the Title V and PSD permit applications, which shall include, but not be limited to, date(s) of submission of the application and required modeling (if applicable); 3.) the results of any subsequent performance testing conducted prior to issuance of the Title V permit; 4.) a schedule with milestone dates for the ordering, construction and/or installation, and operation of control technology; and 5.) any additional pertinent information showing progress and efforts to achieve and maintain compliance with the Act and Air Quality Regulations. The progress reports shall be postmarked by the fifteenth of each month detailing the actions taken by the Respondent during the preceding month.

IV.

To submit to the Enforcement Division, within thirty (30) days after receipt of this **COMPLIANCE ORDER**, a written report that includes a detailed description of the circumstances surrounding the cited violation(s) and actions taken or to be taken to achieve compliance with the Order

THE RESPONDENT SHALL FURTHER BE ON NOTICE THAT:

I.

The Respondent has a right to an adjudicatory hearing on a disputed issue of material fact or of law arising from this **COMPLIANCE ORDER**. This right may be exercised by filing a written request with the Secretary no later than thirty (30) days after receipt of this **COMPLIANCE ORDER**.

II.

The request for an adjudicatory hearing shall specify the provisions of the **COMPLIANCE ORDER** on which the hearing is requested and shall briefly describe the basis for the request. This request should reference the Enforcement Tracking Number and Agency Interest Number, which are located in the upper right-hand corner of the first page of this document and should be directed to the following:

III.

Upon the Respondent's timely filing a request for a hearing, a hearing on the disputed issue of material fact or of law regarding this **COMPLIANCE ORDER** may be scheduled by the Secretary of the Department. The hearing shall be governed by the Act, the Administrative Procedure Act (La. R.S. 49:950, et seq.), and the Division of Administrative Law (DAL) Procedural Rules. The Department may amend or supplement this **COMPLIANCE ORDER** prior to the hearing, after providing sufficient notice and an opportunity for the preparation of a defense for the hearing.

IV.

This **COMPLIANCE ORDER** shall become a final enforcement action unless the request for hearing is timely filed. Failure to timely request a hearing constitutes a waiver of the Respondent's right to a hearing on a disputed issue of material fact or of law under Section 2050.4 of the Act for the violation(s) described herein.

V.

The Respondent's failure to request a hearing or to file an appeal or the Respondent's withdrawal of a request for hearing on this **COMPLIANCE ORDER** shall not preclude the Respondent from contesting the findings of facts in any subsequent penalty action addressing the same violation(s), although the Respondent is estopped from objecting to this **COMPLIANCE ORDER** becoming a permanent part of its compliance history.

VI.

Civil penalties of not more than twenty-seven thousand five hundred dollars (\$27,500) for each day of violation for the violation(s) described herein may be assessed. For violations which occurred on August 15, 2004, or after, civil penalties of not more than thirty-two thousand five hundred dollars (\$32,500) may be assessed for each day of violation. The Respondent's failure or refusal to comply with this **COMPLIANCE ORDER** and the provisions herein will subject the Respondent to possible enforcement procedures under La. R.S. 30:2025, which could result in the assessment of a civil penalty in an amount of not more than fifty thousand dollars (\$50,000) for each day of continued violation or noncompliance.

VII.

For each violation described herein, the Department reserves the right to seek civil penalties in any manner allowed by law, and nothing herein shall be construed to preclude the right to seek such penalties.

NOTICE OF POTENTIAL PENALTY

I.

Pursuant to La. R.S. 30:2050.3(B), you are hereby notified that the issuance of a penalty assessment is being considered for the violation(s) described herein. Written comments may be filed regarding the violation(s) and the contemplated penalty. If you elect to submit comments, it is requested that they be submitted within ten (10) days of receipt of this notice.

II.

Prior to the issuance of additional appropriate enforcement action(s), you may request a meeting with the Department to present any mitigating circumstances concerning the violation(s). If you would like to have such a meeting, please contact Antoinette Cobb at (225) 219-3072 within ten (10) days of receipt of this **NOTICE OF POTENTIAL PENALTY**.

III.

The Department is required by La. R.S. 30:2025(E)(3)(a) to consider the gross revenues of the Respondent and the monetary benefits of noncompliance to determine whether a penalty will be assessed and the amount of such penalty. Please forward the Respondent's most current annual gross revenue statement along with a statement of the monetary benefits of noncompliance for the cited violation(s) to the above named contact person within ten (10) days of receipt of this **NOTICE OF POTENTIAL PENALTY**. Include with your statement of monetary benefits the method(s) you utilized to arrive at the sum. If you assert that no monetary benefits have been gained, you are to fully justify that statement. If the Respondent chooses not to submit the requested most current annual gross revenues statement within ten (10) days, it will be viewed by the Department as an admission that the Respondent has the ability to pay the statutory maximum penalty as outlined in La. R.S. 30:2025.

IV.

The Department assesses civil penalties based on LAC 33:I.Subpart1.Chapter7. To expedite closure of this **NOTICE OF POTENTIAL PENALTY** portion, the Respondent may offer a settlement amount to resolve any claim for civil penalties for the violation(s) described herein. The Respondent may offer a settlement amount, but the Department is under no obligation to enter into settlement negotiations. The decision to proceed with a settlement is at the discretion of the Department. The settlement offer amount may be entered on the attached "**CONSOLIDATED COMPLIANCE ORDER AND NOTICE OF POTENTIAL PENALTY REQUEST TO CLOSE**" form. The Respondent must include a justification of the offer. **DO NOT** submit payment of the offer amount with the form. The Department will review the settlement offer and notify the Respondent as to whether the offer is or is not accepted.

v.

This **CONSOLIDATED COMPLIANCE ORDER & NOTICE OF POTENTIAL PENALTY**
is effective upon receipt.



The following **CONSOLIDATED COMPLIANCE ORDER & NOTICE OF POTENTIAL PENALTY** is issued to **LASALLE BIOENERGY LLC (RESPONDENT)** by the Louisiana Department of Environmental Quality (the Department), under the authority granted by the Louisiana Environmental Quality Act (the Act), La. R.S. 30:2001, et seq., and particularly by La. R.S. 30:2025(C), 30:2050.2 and 30:2050.3(B).

FINDINGS OF FACT

I.

The Respondent owns and/or operates a plywood manufacturing facility, Agency Interest No. 185544, and a wood pellet processing facility, Agency Interest No. 1565, as listed in the table below:

II.

On or about February 12, 2019, file reviews of LaSalle BioEnergy LLC, Agency Interest Nos. 1565 and 185544, were performed to determine the degree of compliance with the Louisiana Environmental Quality Act (the Act) and the Air Quality, Water Quality Regulations, and Louisiana Pollutant Discharge Elimination System (LPDES) Permit No. LAG480349, Air Quality Permit No. PSD-LA-733-(M-1), and Title V Permit No. 1680-00097-V1/V2. LaSalle BioEnergy LLC, Agency Interest No. 1565, operates under LPDES Permit No. LAG480349. LaSalle BioEnergy LLC, Agency Interest No. 185544, operates under Air Quality Permit No. PSD-LA-733-(M-1) and Title V Permit No. 1680-00097-V1/V2.

While the Department's investigation is not yet complete, the following violations were noted during the course of the file reviews:

- A. The Respondent became the owner/operator of Agency Interest Nos. 1565 and 185544 on April 25, 2017. The Notification of Change Form (NOC-1) was postmarked on June 8, 2017. The failure to submit the NOC-1 and associated documentation to the Department within forty-five (45) days after a change in ownership of each permitted facility is a violation of LAC 33:I.1907.B; LAC 33:III.517.G, and La. R.S.30:2057(A)(2).
- B. The unauthorized operation of the facility, Agency Interest No. 185544, without authorization under a Title V Permit and/or a PSD Permit, from the date the facility was acquired on April 25, 2017, until the permits were transferred on August 31, 2017, is a violation of LAC 33:III.501.C.2 and La. R.S. 30:2057(A)(1) and 30:2057(A)(2).

C. The Respondent caused and/or allowed the discharge of wastewater without a permit and/or other authority from the Department. Specifically, the Respondent operated the facility, Agency Interest Number 1565, from April 25, 2017 until August 31, 2017, when a LPDES permit LAG480349 was transferred. The Respondent submitted a Discharge Monitoring Report (DMR) for the June monitoring period, that indicated a discharge had occurred from the facility. This is a violation of La. R.S. 30:2075.

D. The Respondent reported the following violations for Agency Interest No. 185544, from permitted operating parameters:

Each failure to operate each equipment on each day according to the permit requirements is a violation of any applicable permit and associated requirement(s) listed above, LAC 33:III.501.C.4, La. R.S. 30:2057(A)(1), and 30:2057(A)(2).

- E. The Respondent failed to submit the 2017 First Half Semiannual Monitoring Report, 2017 Second Half Semiannual Monitoring Report, and the 2017 Annual Compliance Certification in a timely manner. Specifically, the 2017 First Half Semiannual Monitoring Report was postmarked on February 19, 2018, after the September 30, 2017 due date. The 2017 Second Semiannual Monitoring Report and the 2017 Annual Compliance Certification were postmarked on April 2, 2018, after the March 31, 2018 due date. Each late report submittal is a violation of Specific Requirement No. 42 of Title V Permit No. 1680-00097-V1, LAC 33:III.535, General Condition K, M, R, and La. R.S. 30:2057(A)(2).
- F. The Respondent failed to submit the Title V Permit No. 1680-00097-V1 renewal six (6) months prior to the May 28, 2018 expiration date. The Title V Permit No. 1680-00097-V0 was issued on May 28, 2013. The Respondent submitted a Title V Permit No. 1680-00097-V1 renewal application on May 21, 2018. This is a violation of Specific Requirement No. 42 of Title V Air Permit No. 1680-00097-V1, LAC 33:III.507.E.4, and La. R.S. 30:2057(A)(2).
- G. Based on the file reviews as stated in FOF paragraph II, the Respondent failed to perform a stack test for volatile organic compounds (VOC) per Specific Requirement Nos. 3 & 4 of Title V Air Permit No. 1680-00097-V2 for one of the Dry Mill Filters EQT0009-0016 within 180 days of August 27, 2018, which was February 22, 2019. This is a violation of Specific Requirement Nos. 3 & 4 of Title V Air Permit No. 1680-00097-V2, LAC 33:III.501.C.4, and La. R.S. 30:2057(A)(2).

- H. The Respondent operated the facility without a Title V permit from May 29, 2018, to August 26, 2018. Each day of the operation of the facility which resulted in unpermitted emissions without a permit is a violation of LAC 33:III.501.C.2, and La. R.S. 30:2057(A)(1) and 30:2057(A)(2).
- I. The Respondent reported in the 2019 First Half Semiannual that the facility failed to conduct opacity readings as required in Title V Permit No. 1680-00097-V2, as shown in the table below.
