LDEQ Secretary Aurelia S. Giacometto Hosts Stakeholders for Summit on New Agency Dashboard and Permitting System

Baton Rouge, Louisiana — **August 29, 2024:** The Louisiana Department of Environmental Quality (LDEQ) hosted more than 80 industry leaders and stakeholders from around the state and the country July 10 – 11 for the LDEQ Innovation Summit. The summit focused on the agency's new effort to create a Dashboard and streamlined electronic permitting system — and attendees reported back significant positive feedback on the progress being made to identify systems.

"Online permitting will create efficiencies and allow us to be competitive," LDEQ Secretary Aurelia S. Giacometto told the group, "Louisiana has vast natural resources to attract industry and new jobs, and we want our technologies to enable us to fully contend with other states in enticing new business and protecting the environment."

In February, Governor Jeff Landry proclaimed Executive Order JML 24-17 directing LDEQ and LDENR to streamline permitting processes for the oil and gas industry. LDEQ has applied that direction to every industry that LDEQ approves permits for, meaning the new online permitting system will be open to all.

The Innovation Summit served as a collaborative format for the agency to engage the public and industrial businesses that LDEQ regulates. Attendees — from CEOs and elected officials to permit writers and consultants — offered valuable insights and surprise for LDEQ's willingness to engage them in deep analysis. Those insights gained from attendees will be incorporated as the agency continues to move toward the launch of the new LDEQ Dashboard and online permitting system.

LDEQ will be working to transition its IT systems to a more seamless format that provides transparency to users and accountability to the agency. To date, the agency has invested more than 2,800 hours to delineate almost 20 IT and data systems that enable internal and external functions.
